NOTICE TO EMPLOYERS

The \$2.59 per hr increase effective July 1, 2007 has been allocated as follows: 1.98 cents per hr to wages, .03 cent per hr I.U. Dues check-off, .03 cent per hr Local 1 Dues Check-Off, .25 cents per hr to the Insurance & Welfare Fund, .25 cents per hr to Local Pension Fund, .05 to I.M.I. Effective 7/1/07 Wages & Fringe Benefit contributions has been increased to \$65.80 per hr. The wage breakdown is as follows:
